REPORT OF THE INSPECTION COMMITTEE CONSTITUTED FOR RENEWAL/EXTENSION OF TEMPORARY AFFILIATION AS WELL AS ENHANCEMENT OF INTAKE CAPACITY OF R.B. COLLEGE OF EDUCATION, RAJBAGH, KATHUA, FOR THE SESSION 2022-23.

In pursuance to letter No.CDC/2022/4895-4900 dated 17.12.2022 read with letter No.CDC/2022/5077-79 dated 23.12.2022, the committee constituted vide order No. CDC/2022/4297-4300 dated 15.11.2022 visited the college on 27.12.2022 at 3.00 p.m.

Soon after arrival, the college presented a power point presentation highlighting the objectives of the Institute and the infrastructure raised by it. After preliminary interaction with the Principal, teaching staff after scrutinizing the documents submitted by the college to the University, the committee observed that earlier the college was established in ~~top floor~~ of DPS building with the intake of one unit i.e. 50 candidates with the condition that the seats shall be enhanced when the college is shifted in its own building. Now the college has been shifted in its own newly constructed building and the available infrastructure is sufficient to accommodate 100 students.

Besides Principal, the college has appointed 08 faculty members out of which three faculty members are appointed by the college management on adhoc basis. The college has also appointed eligible librarian on adhoc basis. The committee also observed that the college has complied the deficiencies pointed out during earlier inspection.

The college has adequate number of books in the library. During the current financial year 2021-22, the college has purchased more books worth Rs.24962/-. All the books are properly catalogued. The college has well furnished computer lab.

The college has maintained the accounts registers. Salary is being paid to the staff through on-line mode as well as through cheque. The committee observed that EPF has not being deducted from salary. The college management was directed to deduct the EPF from the eligible faculty and also disburse the salary to the entire faculty as well as supporting staff through on-line mode.

Last meeting the managing committee was conducted on 17.01.2022. As per norms, the managing committee shall meet twice in a year. Accordingly, the college management was directed to convene the next meeting of the managing committee at the earliest.

The college has constituted various committees, such as, Sports and Cultural Committee, Internal complaints committee, grievance redressal committee, anti ragging committee, Admission committee etc.

Recommendations:

Keeping in view that the admission process for the current session has already been completed, the committee recommends that temporary affiliation of the college for the session 2022-23 be extended with the existing intake i.e. 50 seats subject to the condition that the college shall submit the compliance report within fifteen days from the date of issuance of report,

The committee further recommends that the intake of the college be enhanced from one unit to two units (i.e. 100 seats) from the next session i.e. 2023-24 subject to the condition that the college appoints the adequate teaching faculty as per NCTE norms before the start of next session.
